1. I will be responsible for all electric bills from the date a tenant closes the account until a new tenant applies for service, or until service is ordered disconnected.
2. AMP will not be responsible for the resolution of any dispute between my tenants and me regarding effective dates of service.
3. Electric bills for all accounts need to be paid by the due date. Any delinquent balances on my account may be subject to collection action and a security deposit may be assessed.
4. Any delinquent balances on closed accounts may be transferred into any of my active accounts without prior notice from AMP.
5. This agreement does not apply in cases where a tenant's service has been disconnected for non-payment.
6. I will notify AMP of any changes to my mailing address, property ownership or management.
7. I will provide thirty (30) days written notice to AMP to cancel this no seal agreement.
8. The account establishment fee will be waived each time an account is transferred into my name when a tenant moves out and requests discontinuance of service.
9. AMP reserves the right to cancel this agreement at any time without written notification should the account become delinquent or in violation of any terms and condition stipulated herein.
