## SCHEDULE CT GENERAL SERVICE – DEMAND METERED

### APPLICABILITY

This schedule is applicable to 115 kV service to the Northern California Power Agency (NCPA) Combustion Turbine Installation pursuant to agreement between Alameda Municipal Power (AMP) and NCPA.

### STATE TAXES

Applicable state taxes (refer to Rider ERS for current tax rate), charges for the state solar photovoltaic (PV) program (refer to Rider PV), and the energy adjustment charge (refer to Rider EAC) will be added to the above charges.

### DEFINITIONS AND SPECIAL CONDITIONS

- 1. DISTRIBUTION CHARGE**  
The charge for delivery of electric power at the local level, including billing and metering costs
- 2. PUBLIC PURPOSE CHARGE**  
The California state-mandated charge supporting the funding of energy efficiency, new renewable resources, low income and research and development programs
- 3. GENERATION CHARGE**  
The charge for recovering the cost of providing energy supply, including generation and transmission costs
- 4. METERED DEMAND**  
The Metered Demand in any month is the maximum average power taken per meter during any 15-minute interval in the month, provided that, in case the load is intermittent or subject to violent fluctuations, AMP may use a 1-minute or 5-minute interval instead of a 15-minute interval.
- 5. PRIMARY VOLTAGE DISCOUNT**  
A voltage discount of 4.5 percent will be applied to all charges except taxes provided delivery continues to be made from AMP's 115 kV distribution line.
- 6. POWER FACTOR**  
Charges for any month as computed above will be adjusted for the power factor according to Rider PF.

- 7. STATE SOLAR PV CHARGE**  
Charges for the California state-mandated rebate for solar PV installations under Senate Bill 1
- 8. ENERGY ADJUSTMENT CHARGE**  
The charge per kWh which provides for the recovery of power supply and purchased power related costs incurred by Alameda Municipal Power to serve customers that are not adequately recovered in the base rates. These costs include market purchases, hydropower availability impacts, and other power supply related charges.
- 9. RULES and REGULATIONS**  
Other conditions, as specified in AMP's Rules and Regulations, shall apply to this electric rate schedule.
