STATE TAXES

Applicable state and local taxes (refer to Rider UUT and Rider ERS for current tax rates), charges for the state solar photovoltaic (PV) program (refer to Rider PV), and the energy adjustment charge (refer to Rider EAC) will be added to the above charges.

DEFINITIONS AND SPECIAL CONDITIONS

- 1. BASELINE RATES**
Baseline rates are applicable only to residential usage billed under a residential rate schedule.
- 2. DISTRIBUTION CHARGE**
The charge for low voltage delivery of electric power at the local level, including billing and metering costs
- 3. PUBLIC PURPOSE CHARGE**
The California state-mandated charge supporting the funding of energy efficiency, new renewable resources, low income and research and development programs
- 4. GENERATION CHARGE**
The charge for recovering the cost of providing energy supply, including generation and transmission costs
- 5. TIER I (BASELINE) & TIER II (130% BASELINE) QUANTITIES**
Baseline quantities vary for summer and winter seasons and depend on the primary heat source (gas or electric). The following quantities of electricity are to be billed at the Tier I and Tier II rates for Baseline usage:

6. SEASONAL RATE CHANGES

Summer and winter Tier I and Tier II (Baseline) quantities will normally be billed without seasonal proration for six consecutive billing periods starting with the beginning of the May and November billing cycles, respectively.

7. STATE SOLAR PV CHARGE

Charges for the California state-mandated rebate for solar PV installations under Senate Bill 1

8. ENERGY ADJUSTMENT CHARGE

The charge per kWh which provides for the recovery of power supply and purchased power related costs incurred by Alameda Municipal Power to serve customers that are not adequately recovered in the base rates. These costs include market purchases, hydropower availability impacts, and other power supply related charges.

9. RULES and REGULATIONS

Other conditions, as specified in AMP's Rules and Regulations, shall apply to this electric rate schedule.
