Definitions:

- UUT - Utility user's tax (City tax on all utility services)
- ERS - Energy resource surcharge (funds California Energy Commission)
- EAC - Energy Adjustment Charge
- PV - Rider for solar surcharge per Senate Bill 1
- ERG - Eligible Renewable Generation excess generation compensation rate
- Distribution - Wires, poles, transformers, meters, etc.
- Public Purpose - State mandated charge supporting funding of energy efficiency, new renewable resources, low income, and R&D
- Generation - Cost of providing energy supply to Alameda, including generation and transmission costs
